## **APPLICATION OF AGREEMENT**

This Agreement shall apply to the Northern Hotel, Hospital, Restaurant and Related Trades Employees Industrial union of Workers, all workers employed on the Auckland waterfront by Nationwide Food Services (N.Z.) Limited in cafeterias run on behalf of the Waterfront Industry Commision, the Union Steam Ship Co. and the Auckland Harbour Board at the Marsden, Bledisloe and Fergusson Wharves.

#### WAGES

Amend the wages clauses in the NZ Tearoom and Restaurant Employees Award by deleting the present provisions of clauses 11(b) and (e), 12(c) i, ii and iii, and insert the following wage scale:

Kitchen Hand Full Time	\$6.021 per hour
Kitchen hand Part-Time	\$6.074 per hour
Third Cook (U.S.S.Co.)	\$6.074 per hour
Kitchen Hand personal to holder rate	\$6.81 per hour
Cook (USSCo)	\$6.491 per hour
Supervisor (W.I.C.)	\$6.279 per hour
Supervisor (A.H.B.)	\$7.40 per hour
Supervisor (A.H.B.)	\$7.565 per hour
Cook (W.I.C.)	\$7.294 per hour
Cook (U.S.S.Co.)	\$7.565 per hour
Cook (A.H.B.)	\$7.884 per hour
Cook (A.H.B.)	\$7.907 per hour
First Cook (W.I.C. & A.H.B.)	\$8.84 per hour

Wages payable under this agreement include a flat .32 cent allowance in full satisfaction of all claims that might otherwise arise due to location and other industry related payments applying within the designated wharf limits of the Port of Auckland. This allowance will be escalated in accordance with the provisions of the escalation clause prescribed in this agreement.

## **ESCALATION CLAUSE**

All remuneration specified in this agreement shall be adjusted by the same percentage movement applying to wages in the New Zealand Tearooms and Restaurant Employees Award whenever that document is renewed.

#### **GENERAL**

Except as herein modified the terms of employment of all workers bound by this agreement shall be in accordance with the New Zealand Tearoom and Restaurant Employees Award in force from time to time.

## **TERM OF AGREEMENT**

This agreement shall come into force on the 1 July 1985 and shall continue in force until the 28th day of February 1987.
