# REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the Pacific Steel Limited and Pacific Metal Industries Limited Electrical Workers dispute of interest between NZ (except Canterbury and Westland) Electrical, Electronics and Related Trades Industrial Union of Workers and Pacific Steel Limited and Pacific Metal Industries Limited

THE Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

- 2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

## 1. WAGE AGREEMENT

- (a) An electrician who has completed an apprenticeship in the electrical industry and who has obtained his Trade Certificate in electrical theory and practice or equivalent examination acceptable to the Electricians' Registration Board, \$8.64.5 hourly rate.
- (b) To fully cover all working conditions and operations as they apply in the National Award and those that may arise in the performance of the normal and expected duties of the electricians employed in the steelworks, yard and melting shop of the Employer, an amount of 17.3 cents per hour is added.
  - (c) The hourly rate in total \$8.81.8 per hour.
- (d) Temperature money shall be paid on an individual basis in accordance with the Award current at this time.
- (e) A registered Electrician who holds the Electricians' Advanced Trade Certificate shall be paid 30.0 cents per hour in addition to the rate prescribed in subclause (c) of this Clause. Where a Registered Electrician or an Electrical Technician holds a second Advanced Trade Certificate he shall be paid an additional 30.0 cents per hour.
  - (f) (i) A Registered Electrician who holds NZCE (Electrical or Related Trade) shall be paid 30.0 cents per hour in addition to the rates prescribed in subclause (e) and (c) of this Clause.
    - (ii) A Registered Electrician who holds NZCE (Electrical or Related Trade) and is not a holder of Trade Certificates as in subclause (e) of this Clause, shall be paid a premium rate of 90.0 cents per hour.
- (g) A Registered Electrician who has obtained Registration as an Electrical Technician and covered by this Agreement shall be paid 43.9 cents per hour in addition to the rate prescribed in subclause (c) of this Clause.
- 2. Shift workers shall be paid a shift allowance of \$9.65 per shift.

## 3. SERVICE ALLOWANCE

- (i) For service exceeding 6 months 16.0 cents per hour
- (ii) For service exceeding 1 year 25.6 cents per hour
- (iii) For service exceeding 2 years 29.4 cents per hour
- (iv) For service exceeding 3 years 32.7 cents per hour
- (v) For service exceeding 4 years 36.0 cents per hour

- (vi) For service exceeding 5 years 39.1 cents per hour
- (vii) For service exceeding 6 years 43.6 cents per hour
- (viii) For service exceeding 7 years 46.8 cents per hour
- (ix) For service exceeding 8 years 50.0 cents per hour
- (x) For service exceeding 9 years 53.2 cents per hour
- (xi) For service exceeding 10 years 56.4 cents per hour
- (xii) For service exceeding 11 years 59.0 cents per hour
- (xiii) For service exceeding 12 years 61.5 cents per hour
- (xiv) For service exceeding 13 years 64.1 cents per hour
- (xv) For service exceeding 14 years 66.6 cents per hour
- (xvi) For service exceeding 15 years 67.9 cents per hour
- (xvii) For service exceeding 16 years 69.9 cents per hour
- (xviii) For service exceeding 17 years 71.9 cents per hour
  - (xix) For service exceeding 18 years 73.7 cents per hour
  - (xx) For service exceeding 19 years 75.7 cents per hour
  - (xxi) For service exceeding 20 years 77.5 cents per hour

Continuous service now accrued qualifies for the allowance.

Service must be continuous so that if a worker leaves or is discharged and returns to the employer, he commences afresh without service allowance and his qualification for the allowance runs from the date of return.

# 4. MEAL ALLOWANCE

Will be \$5.00 per meal.

#### 5. CHARGE ALLOWANCE

Workers delegated by Management responsible for workers under their control shall receive in addition to the rate Clause 1(c)

- (i) Central Maintenance Services 75.0 cents per hour as Chargehand.
- (ii) All others 57.95 cents per hour as Chargehand.

### 6. TOOL ALLOWANCE

The following minimum list of tools shall be provided by each Tradesman to qualify for payment of tool allowance of 20.7 cents per hour.

Replacement of tools to meet the requirements of metrication, will be at the employee's expense. Tools lost or stolen shall be the replacement responsibility of the worker concerned.

Burglary of tools from a locked tool locker will be reported by the individual employee to the Police and insurance claim form completed and handed to the Employer for action.

## 7. ANNUAL HOLIDAYS

As per Award. Annual Holidays (15) with paragraph 15 (b) after 6 years to read 5 years in both places.

#### 8. REDUNDANCY

Three months' notice will be given in order that discussion can take place between the Employer and Union.

# TERM OF AGREEMENT

This Agreement in as far as the provisions relating to the Agreement are concerned shall be deemed to have come into force on the first day of the pay week commencing on or after the 11th day of February 1986 and continue in force until the 10th day of February 1987.

#### **MEMORANDUM**

This collective agreement incorporates the terms of voluntary settlement arrived at by the parties and forwarded to the Court for registration pursuant to section 65 of the Industrial Relations Act.

The Court has, pursuant to section 92 (2) of the Industrial Relations Act 1973, consented to the specified period for which this collective agreement is to continue in force being less than one year from the date of registration.

Section 17 of the Industrial Relations Amendment Act 1985, Transitional Provision in Respect of Unqualified Preference Provisions, says that every collective agreement or award subject to section 17, shall be deemed to contain a union membership clause in the same form as set out in section 98 of the Industrial Relations Act 1973. The union membership clause reads as follows:

"If any adult person (other than a person who holds a certificate of exemption from union membership issued under section 1120 of the Industrial Relations Act 1973) who is not a member of a union of workers bound by this agreement is enagaged or employed by any employer bound by this agreement, in any position or employment that is subject to the agreement, the person shall become a member of the union within 14 days after that person's engagement or, as the case may require, after this clause comes into force, and shall remain a member of the union so long as that person continues in the position or employment."
