1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

**TERMS OF AGREEMENT BETWEEN FELTEX COLORTRON
CARPETS FOXTON AND THE WELLINGTON BRANCH NEW
ZEALAND ENGINE DRIVERS, FIREMEN, GREASERS AND
ASSISTANTS INDUSTRIAL UNION OF WORKERS COVERING
MEMBERS OF THE UNION EMPLOYED AT THE COMPANYS
PLANT FOXTON**

Workers covered by this Agreement shall be bound by the New Zealand Engine Drivers, Boiler Attendants, Firemen and Greasers Award for the time being current, except in respect of matters dealt with in the following clauses of this Agreement.

This Agreement shall come into force on the 1st January 1986 and continue in force until it expires on 31st December 1986.
