### **SCHEDULE**

### 1. APPLICATION OF AGREEMENT

This Agreement shall apply to the Wellington District Hotel, Hospital, Restaurant and Related Trades Employees' Industrial Union of Workers, all workers employed at the Wellingon Post Office Headquarters Building Cafeteria and the Post Office Headquarters Building Cafeteria Committee.

### 2. WAGES

Cooks shall be paid \$278.40 per week for weekly workers or \$6.96 per hour for part-time or casual workers.

All other workers shall be paid \$262.80 per week for weekly workers or \$6.57 an hour for part-time or casual staff.

### 3. GENERAL

Except as herein modified the terms of employment of all workers bound by this agreement shall be in accordance with the terms and conditions of the New Zealand Tearoom and Restaurant Employees Award in force from time to time.

### 4. TERM OF AGREEMENT

This agreement shall come into force on the 19th day of March 1986 and continue in force until the 18th day of March 1987.
