**REGISTERED COLLECTIVE AGREEMENT**

In the matter of the Industrial Relations Act 1973; and in the matter of the Manukau City Council Catering Workers Dispute of Interest

between the Northern Hotel, Hospital, Restaurant and Related Trades' Employees Industrial Union of Workers and the Manukau City Council.

THE Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 27th day of June 1986.

1. **APPLICATION OF AGREEMENT**

This Agreement shall apply to the Northern Hotel, Hospital, Restaurant and Related Trades Employees Industrial Union of Workers, all workers employed in the staff cafeteria at Manukau City Council, Manukau City, Auckland, and the East Tamaki Depot Cafeteria.

2. **WAGES**

Chief Cook — Administration Building .....	\$9.67 per hour
Chief Cook — East Tamaki Depot .....	\$8.97 per hour
Second Cook — Administration Building .....	\$7.06 per hour
Second Cook — East Tamaki Depot .....	\$6.69 per hour
Kitchenhand—Counterhand—Waitress (full-time) .....	\$6.53 per hour
Kitchenhand—Counterhand—Waitress (casual) .....	\$6.58 per hour

3. **GENERAL**

Except as herein modified the terms of employment of all workers bound by this Agreement shall be in accordance with the New Zealand Tearoom and Restaurant Employees Award in force from time to time.

4. This Agreement shall come into force from the 1st day of April 1986 shall continue in force until the 31st day of March 1987.
