VOLUNTARY SETTLEMENT

1. This Agreement shall apply to the Wellington District Hotel Hospital, Restaurant and Related Trades Employees Industrial Union of Workers and all workers employed in the Wellington Wharf Cafeteria run on behalf of the Waterfront Industry Commission.

2. WAGES

Amend the wages clauses in the NZ Tearoom and Restaurant Employees Award by deleting the present provisions of clauses 11(b) and (e), 12(c) i, ii, and iii, and insert the following wage scale:

Kitchen Hand \$6.00 per hour Charge Hand \$6.00 per hour Cook \$6.25 per hour Snr Charge Hand \$6.50 per hour Chief Cook \$7.00 per hour Chief Cook

3. ESCALATION CLAUSE

All remuneration specified in this agreement shall be adjusted by the same percentage movement applying to wages in the New Zealand Tearooms and Restaurant Employee Award whenever that document is renewed.

4. GENERAL

Except as herein modified the terms of employment of all workers bound by this agreement shall be in accordance with the New Zealand Tearooms and Restaurant Employees Award in force from time to time.

5. TERM OF AGREEMENT

This Agreement shall come into force on the 30th September 1985 and shall continue in force until the 28th day of February 1987. Dated at Wellington this 18th day of November 1985. The Wellington District Hotel, Hospital, Restaurant and Related Trades Employees Industrial Union of Workers.
