#### **SCHEDULE**

#### 1. APPLICATION OF AGREEMENT

This agreement shall apply to the Northern Hotel, Hospital, Restaurant and Related Trades Employees' Industrial Union of Workers, all workers employed in the staff cafeteria in the Auckland Wellesley Street Toll Exchange and the Auckland Wellesley Street Toll Exchange Cafeteria Committee.

#### 2. WAGES

The supervisor shall be paid \$5.71 per hour and any assistant shall be paid \$5.32 per hour. This payment represents an above award payment of 10 percent.

#### 3. ESCALATION CLAUSE

All remuneration specified in this agreement shall be adjusted by the same percentage movement applying to wages in the New Zealand Tearooms and Restaurant Employees' Award whenever the document is renewed.

#### 4. GENERAL

Except as herein modified the terms of employment of all workers bound by this agreement shall be in accordance with the New Zealand Tearooms and Restaurant Employees' Award in force from time to time.

#### 5. TERM OF AGREEMENT

This agreement shall come into force on the 15th day of November 1985 and shall continue in force until the 14th day of November, 1986.
