## REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the New Zealand Apple and Pear Marketing Board, Nelson, Engine Drivers, Boiler Attendants, Firemen and Greasers Dispute of Interest between the New Zealand Apple and Pear Marketing Board (Nelson) and the New Zealand Engine Drivers, Firemen, Greasers and Assistants Industrial Union of Workers

THE Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 17th day of July 1986.

**TERMS OF AGREEMENT BETWEEN THE NEW ZEALAND ENGINE DRIVERS, FIREMEN, GREASERS, AND ASSISTANTS UNION AND THE NEW ZEALAND APPLE AND PEAR MARKETING BOARD, NELSON.**

**1. MATTERS NOT PROVIDED FOR**

The workers covered by this agreement shall continue to be bound by the New Zealand Engine Drivers, Boiler Attendants, Firemen and Greasers current award except in respect of matters dealt with in the following clauses of this agreement.

**(a) Scope**

This Agreement shall apply to members of the N.Z. Engine Drivers, Firemen, Greasers and Assistants Union employed at New Zealand Apple & Pear Marketing Board, Nelson.

**2. WAGES**

Holders of First Class Certificates .....	\$8.514 per hour
Holders of 2nd Class Certificates.....	\$8.289 per hour
Holders of Boiler Attendants Certificates .....	\$7.872 per hour

**3. SERVICE PAY**

After 6 months' current continuous service.....	22 cents per hour
After 1 year's current continuous service.....	32 cents per hour
After 2 years' current continuous service.....	36 cents per hour
After 3 years' current continuous service.....	42 cents per hour
After 4 years' current continuous service.....	46 cents per hour
After 5 years' current continuous service.....	50 cents per hour
After 6 years' current continuous service.....	56 cents per hour

**4. QUALIFICATION PAYMENT**

Holders of 2nd Class Certificates.....	44.2 cents per hour
Holders of Boiler Attendants Certificates .....	28.1 cents per hour
