**Under the Industrial Relations Act 1973
REGISTERED COLLECTIVE AGREEMENT**

In the matter of the Industrial Relations Act 1973; and in the matter of the Auckland By-Products Ltd Stationary Engine Drivers dispute of interest

between the New Zealand Engine Drivers, Firemen, Greasers and Assistants Industrial Union of Workers and Auckland By-Products Ltd

THE Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and
2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 6th day of June 1986.

**STATIONARY ENGINE DRIVERS OF AUCKLAND/

COLLECTIVE AGREEMENT

1. MATTERS NOT PROVIDED FOR

With the exception of the matters specifically herein, the terms and conditions of the N.Z. Engine Drivers, Boiler Attendants, Firemen and Greasers Award, in force from time to time, shall apply for the term of this agreement.

2. WAGES

	Base Rate	Certificate Payment	Total Cents Per Hour
(a) Boilerman — 2nd Class	\$8.26	30.0¢	856¢

The above rates are to be included in the computation of overtime.

(b) A special boilerhouse condition allowance of 58 cents per hour will be added to the job rate for the computation of wages.

3. HOURS OF WORK

As provided for in Clause 5 of the N.Z. Engine Drivers, Boiler Attendants, Firemen and Greasers Award, in force from time to time, except the shift allowance shall be \$6.44 per shift.

4. TRAVELLING REIMBURSING ALLOWANCE

All workers required to start or cease work between and including the hours of 11am and 6am shall be paid a travelling reimbursing allowance of one hours

pay at ordinary rates. This clause shall not apply where a worker is reasonably able to use public transport or where the worker lives less than 800 metres from his place of work. If the conveyance is provided free of charge for the worker by the employer, he shall not be entitled to payment of travelling reimbursing allowance under this clause.

5. **TERM OF AGREEMENT**

This agreement shall be deemed to have come into force on the 10th November 1985, and shall remain in force until 9th November, 1986.
