#### Terms of Voluntary Settlement under Section 65

#### **SCHEDULE**

1. Notwithstanding the provisions of subclauses (a), (c), (d) and (e) of Clause 1 (Industry to which Agreement Applies) the Taranaki, Wellington, Marlborough, Nelson and Westland Electric Power Boards, Municipal, County Council, Catchment, Drainage, River Boards and other Local Authorities' Officers' Award dated the 20th day of February 1985, together with any amendments thereof, and any Award made, or collective agreement duly registered in substitution therefore, shall apply to all salaried employees of the Nelson Catchment Board with the exception of the General Manager, but subject always to any relevant determination of the Higher Salaries Commission made under the Higher Salaries Commission Act 1977.

2. The following salary scales shall substitute for those specified in paragraph (i); (ii) and (iv) of subclause (a) of clause 6 of the above cited Award:

It is agreed that where the remuneration of any officer bound by this agreement is fixed by or in relation to a determination of the Higher Salaries Commission, the remuneration so fixed shall prevail over the salary scales provided by this agreement.

3. The exemption of the Nelson Catchment Board specified in subclause (a) of clause 26 of the abovenamed Award shall not stand part of this Agreement.

4. If any adult person (other than a person who holds a certificate of exemption from union membership issued under section 1120 of the Industrial Relations Act 1973) who is not a member of a union of workers bound by this agreement is engaged or employed by any employer bound by this agreement, in any position or employment that is subject to the agreement, the person shall become a member of the union within 14 days after that person's engagement or, as the case may require, after this clause comes into force, and shall remain a member of the union so long as that person continues in the position or employment. (EXPLANATORY NOTE IN RELATION TO EXPIRY OF UNION MEMBERSHIP CLAUSE: This clause will expire on 30 November 1989 unless it is extended pursuant to section 101A of the Industrial Relations Act 1973.)

5. This Agreement shall come into force on the 1st day of April 1987 and shall continue in force for one year thereafter.
