NEW ZEALAND FLAT GLASS INDUSTRY - AMENDMENT TO APPRENTICESHIP ORDER

Dated: 25/6/90

IN THE ARBITRATION COMMISSION OF NEW ZEALAND

IN THE MATTER of the Apprenticeship Act 1983;

AND IN THE MATTER of the New Zealand Flat Glass Industry Apprenticeship Order dated the 5th day of August 1988 and recorded in 88 Book of Awards page 7107.

<u>WHEREAS</u> by section 33(1)(b) of the Apprenticeship Act 1983, the Arbitration Commission is empowered to amend any apprenticeship order:

AND WHEREAS application has been made to the Commission by the New Zealand Flat Glass Industry Apprenticeship Committee for amendment of the New Zealand Flat Glass Industry Apprenticeship Order dated the 5th day of August 1988: AND WHEREAS the Commission has considered the recommendations made to it by the said committee:

NOW, THEREFORE, THE COMMISSION, in pursuance and exercise of the powers vested in it by the said Act, <u>DOTH HEREBY ORDER</u> as follows:

- 1. THAT the said apprenticeship order shall be amended in the manner following:
 - By deleting from the list of contents the words "THIRD SCHEDULE ADDITIONAL SKILLS".
 - 2. By deleting the word "three" in subclause 1.1 of clause 1 (Industry to which the Order Applies) and inserting in its place the word "two".
 - 3. By deleting the paragraph under "SCHEDULES" and replacing it with the following:

"The training programme for the industry is based on the common skills prescribed in the first schedule and those of at least one of the specialised sectors of the industry as prescribed in the second schedule".

- 4. By deleting the heading "AUTOMOTIVE GLAZING" from the Third Schedule Additional Skills and replacing it with the word "AUTO-REGLAZING".
- By moving all the Additional Skills (SANDBLASTING AND/OR ACID EMBOSSING 1-5, SILVERING AND POLISHING 1-7, LEADLIGHT WORKING 1-10, AUTO-REGLAZING 1-13) listed in the Third Schedule to the Second Schedule - Specialised Skills and inserting them after "CUTTING, no 11. Care and use of specialist tools in the trade".
- By deleting the words "THIRD SCHEDULE ADDITIONAL SKILLS" from the Schedules.
- 7. By deleting subclause 10.2 of clause 10 (Training Capacity) and replacing it with the following:
 - "10.2. For the purposes of this order a journeyperson shall mean a worker or employer who works substantially at the skills of the industry, and who has completed a contract of apprenticeship or who has obtained a trade certificate in Flat Glass or who has had at least six years experience in the skills prescribed for the industry and can satisfy the District Commissioner or local committee of his or her competence".
- 2. THAT this order shall operate and take effect as from the day of the date hereof.
