s31: Mode of fixing rent to be reserved on renewal of leases

of existing Native reserves.

## Native Trustee Act 1930 continued

*s*32: Authorising Native Trustee to lease Native reserves for periods not exceeding 21 years.

s33: Powers of leasing Poukawa Native reserve.

*s34:* Limitation of area provisions outlined in *ss72 - 75* Native Land Amendment Act 1913 shall not apply to any Native reserve administered by the Native Trustee.

*s35:* On being satisfied that any Native reserve cannot be leased or utilised for the advantage of the beneficial owners, the Native Trustee may sell the land and pay the purchase money to the beneficial owners.

*s36:* Annual rents and proceeds from the Wellington and Nelson tenths.

ss40 - 53: Financial/Native Trustee's Account.

**Commentary:** A consolidation of legislation relating to the Native Trustee

and the administration of Native reserves. Ngata explains that

the amendments are sections 15(3), 24 and 25.
