Native Purposes Act 1931 continued

Relevant Sections:

ss4 - 16: Native Reserves.

s4: Native Trustee may lease lands vested in him under the West Coast Settlement Reserves Act 1892 for a period not exceeding 25 years.

s5: Prospecting and mining for mineral oil on West Coast Settlement Reserves.

s7: Enables Native Trustee to lease certain lands for religious or educational purposes at nominal rental.

s8: Native Trustee may subdivide Native reserves and lay off roads.

s9: Native Trustee authorised to pay to beneficial owners all funds arising from royalties on stone, minerals, timber removed from land as well as compensation received for land taken for Public Work.

s11: Native Trustee declared a leasing authority with respect to Auckland and other Native reserves.

s49: Authorising settlement of Native grievances regarding confiscated land.

s115: Power to adjust rent under Native leases.

*s***117**: Provision for control of Native burial grounds [urupa].

Commentary:

Consolidation of various enactments regarding Maori land which had been found in the Native Land Amendment and Native Land Claims Adjustment Acts, and which were not to be included in the Native Land Act 1931 consolidation. Ngata says that the only new sections are *s*27 and *s*118(*a*).
