

PROTOCOL to the Trade Agreement of 20 April 1959  
between the Government of New Zealand and the Government of  
the Federal Republic of Germany.

Discussions in London between the New Zealand and  
German Delegations pursuant to Article III of the New Zealand  
and German Trade Agreement were terminated today with the  
following provisions:

(a) In accordance with Article III of the Agreement,  
the amounts specified in the Appendix to this Protocol  
shall, for the period 1 April 1961 to 31 March 1962, be  
substituted for the amounts shown in the Annex to the  
Agreement.

(b) For frozen beef New Zealand shall be entitled to  
participate without limitation in any global tenders opened  
during the balance of the quota period 1 April 1961 to  
31 March 1962.

(c) Mutton and lamb may be imported into any part of  
the Federal Republic of Germany including Land Berlin, and  
the conditions of the tenders will be re-examined to ensure  
that they are consistent with this principle. The quota  
shall be opened not later than 30 September 1961 and delivery  
may take place from that date until at least 31 March 1962.

(d) The Government of the Federal Republic of Germany  
gives the assurance that New Zealand will be given the  
opportunity to participate in imports of full cream milk  
powder to the German market.

(e) In respect of imports of cheddar cheese, the Government of the Federal Republic of Germany re-affirms that, if the present system of import licensing of cheddar cheese should be withdrawn by the Government of the Federal Republic of Germany and a system of allocation of quotas to individual countries adopted, New Zealand will be accorded a minimum quota of DM.2,100,000.

(f) It is noted that as imports of honey had been liberalised, this commodity was deleted from the Annex to the Agreement by the Letters exchanged between the two Governments on 25 March 1960.

(g) As imports of blood meal and dried blood for fodder purposes have been made subject to de facto liberalisation, these commodities shall be deleted from the Annex to the Agreement. If, however, imports of these commodities are again made subject to specific quota restrictions, an annual quota shall be opened for New Zealand to a minimum value of at least DM.600,000.

(h) As imports under items Nos. 0702.10, 20, 30, 90 in the German Commodity Index have been liberalised, frozen vegetables shall be deleted from the Annex to the Agreement.

(i) As regards apples and pears, it is agreed that representatives of the two Governments shall meet in November 1961 to discuss the size and conditions of the quota for the 1962/63 period and to determine in particular whether apples and pears may be imported from New Zealand without limitation during certain periods in 1962.

(j) As imports of red clover seed included under the German Commodity Index No. 1203.21 and of grass seeds included under No. 1203.59 have been liberalised, these Index Numbers shall be deleted from the Annex.

(k) As imports of meat extracts have been made subject to de facto liberalisation this commodity shall be deleted from the Annex to the Agreement. However, if imports of this commodity are again made subject to specific quota restrictions an annual quota shall be opened for New Zealand to a minimum value of at least DM.1,000,000.

(l) As imports of canned vegetables included under the German Commodity Index No. 2002.19 have been liberalised, this Index Number shall be deleted from the Annex.

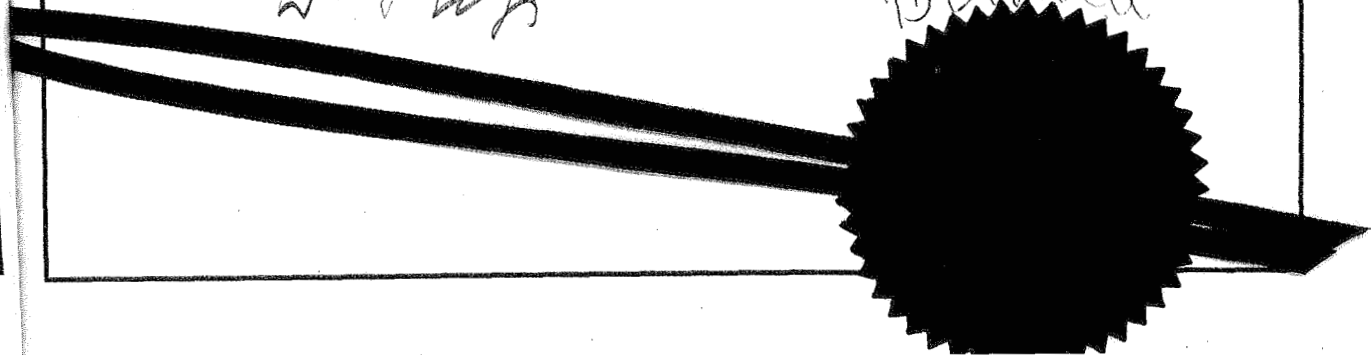
