I have the honour to refer to discussions between representatives of our two Governments concerning arrangements for the continued operation of meteorological and geophysical programmes in Western Samoa after 31 December 1969.

I now have the honour to propose that an agreement should be concluded between our two Governments in the following terms:

- (b) The Government of New Zealand will continue in each year to meet the balance of the operating costs of the meteorological programme which remains after the Government of Western Samoa has paid its share of the costs. The balance shall be met from funds taken from the Aid Programme.
- (c) The Government of New Zealand will continue to provide appropriate advisory support for the meteorological programme.
