I refer to discussions which have taken place between representatives of our respective governments concerning the grant of a loan by the Government of New Sealand to the Government of Western Samos. I now propose on behalf of the Government of New Sealand that an agreement be reached between our two sovernments in the following terms:

- The Covernment of New Yesland will advance to 1 the Government of Western Samos a loan which will be a charge upon the public revenues of Western Semos of the sum of \$150,000 in New Realand currency to be applied by the Government of Western Senos towards the cost of completine Stage Two of the new Legislative Assembly project (Meote Fone), towards the cost of the construction of a building for the Legislative Department, and towards the cost of landscaning the area surrounding the Legislative Assembly project, for Western Samoa. The Severment of New Jealand volcomes the assurance of the Government of Western Samon that New Yealand materials will be used wherever economically feasible in the construction thereof.
- 2. The terms of the loan described in paragraph 1 above shall be 20 years and repayment shall be by 15 equal annual instalments paid by the Government of Mestern Sames to the Government of Mew Zealand currency commencing at the expiration of five years from the date on which the loan or any part thereof is advanced by the Government of Mew Zealand to the Government of Mew Zealand to the Government of Mestern Sames.

If the foregoing provisions are acceptable to the Government of Western Samoa I have the honour to suggest that the present letter and your reply in similar terms should constitute an agreement between our two governments.
