Pending the entry into force of the Protocol initialed today, relating to the establishment of the Multinational Force and Observers, Egypt and Israel appoint Mr. Leamon R. Hunt to act as interim Director-General of the MFO.

The interim Director-General shall have the authority to take the necessary steps to ensure that preparations for the deployment of the MFO in accordance with the Protocol are initiated in a timely fashion. Egypt and Israel shall each immediately make available to the interim Director-General \$20 million, upon which the interim Director-General may draw, as he needs, to make expenditures for these purposes. These contributions shall be reimbursed to the respective State before March 1, 1982, from the budget of the MFO for its financial year 1982.

The interim Director-General shall assume his functions immediately. The interim Director-General shall cease to function upon entry into force of the Protocol and appointment of a Director-General, or on October 1, 1981, whichever comes first. Upon cessation of the functions of the interim Director-General, any unexpended funds will be transferred to the Director-General, or in the event that a Director-General is not appointed by October 1, 1981, returned to the Parties.

I wish to confirm the understandings concerning the United States' role reached in your negotiations on the establishment and maintenance of the Multinational Force and Observers:

- 1. The post of the Director-General will be held by U.S. nationals suggested by the United States.
- 2. Egypt and Israel will accept proposals made by the United States concerning the appointment of the Director-General, the appointment of the Commander, and the financial issues related to paragraphs 24-26 of the Annex to the Protocol, if no agreement is reached on any of these issues between the Parties. The United States will participate in deliberations concerning financial matters. In the event of differences of view between the parties over the composition of the MFO, the two sides will invite the U.S. to join them in resolving any issues.
- 3. Subject to Congressional authorization and appropriations:
- A. The United States will contribute an infantry battalion and a logistics support unit from its armed forces and will provide a group of civilian observers to the MFO.
- B. The United States will contribute one-third of the annual operating expenses of the MFO. The United States will be reimbursed by the MFO for the costs incurred in the change of station of U.S. Armed Forces provided to the MFO and for the costs incurred in providing civilian observers to the MFO. For the initial period

(July 1, 1981 - September 30, 1982) during which there will be exceptional costs connected with the establishment of the MFO, the United States agrees to provide three-fifths of the costs, subject to the same understanding concerning reimbursement.

- C. The United States will use its best efforts to find acceptable replacements for contingents that withdraw from the MFO.
- D. The United States remains prepared to take those steps necessary to ensure the maintenance of an acceptable MFO.

I wish to inform you that I sent today to the Minister of Foreign Affairs of Egypt an identical letter, and I propose that my letters and the replies thereto constitute an agreement among the three States.

Dear Mr. Minister:

I have the honor to refer to the agreement effected by an exchange of letters dated 18 and 19 March, 1982, on the participation of New Zealand in the Multinational Force and Observers (MFO), as subsequently extended in 1984, and related understandings, and to recent discussions I have had in Wellington with New Zealand officials about the terms of continuation of this valued participation.

Based on those discussions, a plan has been developed for support by New Zealand of MFO projects through the provision of specialist teams and detachments which will serially serve with the Force for shorter periods than heretofore. We are particularly pleased at the evolution of this form of participation, which meets the needs of both New Zealand and the MFO in contemplating flexible, specialized response to varied functional requirements of the MFO.

I therefore have the honor of proposing that the participation of New Zealand in the Rotary-Wing Aviation Unit (RWAU), as described in Annex I to the 1982 agreement referred to hereinabove, shall cease on or before 31 March 1986 in accordance with transitional plans to be mutually developed in cooperation with the other present and future RWAU participants, and that New Zealand's contribution thereafter be governed by the Annex to this Note which I propose be

substituted for and entirely replace Annex I of the 1982 Note with effect as of 31 March 1986.

In all other respects, the provisions of the 1982 agreement and related understandings shall continue to govern New Zealand's participation <u>mutatis mutandis</u> in the period after 31 March 1986. However, references in paragraphs 4 and 5 of Annex II of that agreement to "the helicopters" or "helicopters" shall be amended to read "any major items of equipment"; and further, paragraph 6 of Annex II shall be deleted in its entirety, and subsequent paragraphs renumbered accordingly.

If this is agreeable to your Government, I propose that this Note and its Annex, together with your affirmative reply, shall together constitute an agreement effective on the date of your reply.

This Agreement shall continue in force for a period of two years from 31 March 1986, and remain in force thereafter unless New Zealand shall give written notice of twelve months of its intention to withdraw from the agreed mission described in the Annex to this Note or from the Organization, or until such time as the Governments of Egypt and Israel may mutually agree to terminate the mandate of the Organization.

I wish to take this opportunity to thank the Government of New Zealand, on behalf of the those now participating in and sponsoring the MFO, for the valuable continuation of New Zealand's participation on this basis. Please accept the renewed assurances of my highest consideration.

Composition and Mission of the New Zealand Contingent

- 1. The Government of New Zealand shall provide to the MFO a contingent comprising a Headquarters element, and specialist team elements as described below.
- 2. The Headquarters element will comprise the Contingent Commander, whose rank is not to exceed that of Lieutenant Colonel or service equivalent, and an administrative non-commissioned officer. The Headquarters element will provide command of all New Zealand personnel serving with the MFO. Further, this element will be, within the MFO, the liaison center for the formulation of project requests by the MFO to the Government of New Zealand, and the coordination and implementation of projects undertaken by the New Zealand specialist teams. The tour of duty with the Headquarters element will generally be for twelve months, unaccompanied.
- 3. The specialist team element will undertake short-term projects and activities, such as training and advisory missions and engineering projects, as may be mutually agreed from time to time. The size and composition of each team to perform agreed missions will be determined by the Government of New Zealand in consultation with the MFO. Teams will generally be provided on a basis of three such teams every twelve months, and, with the exception of the first team, the duration of the duty period shall be approximately one to three months. The first specialist team, a twelve man Training and Advisory Team, will undertake the design, development and implementation of training programs for MFO ground forces, during a six month tour of duty.
- 4. The Contingent Commander will undertake a mutually agreed appointment on the Force Commander's staff. The status of other New Zealand staff members after 31 March 1986 shall be coordinated between the MFO and the Government of New Zealand.
- 5. Subject to mutual agreement, the MFO shall provide appropriate work and storage space and required specialist and support equipment, shall be responsible for providing all logistic support, and shall provide maintenance beyond contingent capability of contributed specialist and support equipment owned by the New Zealand Contingent, and any MFO-furnished equipment used by the Contingent.
- 6. The Headquarters element, and the first specialist, team shall be fully deployed by 1 May 1986.
- 7. Members of the New Zealand contingent may be armed with their normally assigned individual weapons.
- 8. The mission of the New Zealand contingent as described herein may not be changed without the mutual agreement of the Government of New Zealand and the MFO.
