I have the honour to refer to the Agreement between the Government of the Commonwealth of Australia and the Government of New Zealand relating to Air Services, signed at Wellington on 25 July 1961, as amended by an Exchange of Notes of 18 February and 18 June 1982. In the course of recent consultations it was proposed to delete the existing schedule to the Agreement and replace it with the following schedule:

"(1) Australian Route:

The air services to be operated in both directions by the designated airline of Australia shall be:

- (i) Australia via separate routes to Auckland, Wellington and Christchurch and optionally beyond, and

(2) New Zealand Route:

The air services to be operated in both directions by the designated airline of New Zealand shall be New Zealand via separate routes to Sydney, Melbourne, Brisbane, Norfolk Island, Darwin, Hobart, Perth, Townsville and Adelaide and optionally beyond."

I have the honour to propose that, if the foregoing is acceptable to the Government of New Zealand, this Note and your reply to that effect shall together constitute and evidence an Agreement between our two Governments amending the Agreement which shall enter into force on the date of your reply.
