A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the additional land described in the Schedule hereto is hereby taken for the purposes of a secondary school and shall vest in the Otago Boys' and Girls' High Schools Board as from the date hereinafter mentioned; and I do also declare that this Proclamation shall take effect on and after the thirtieth day of October, one thousand nine hundred and thirty-nine.

SCHEDULE.

APPROXIMATE area of the piece of land taken : 21·8 perches. Being portion of Section 37, Block VII, Town District. (D.P. 2143.)

Situated in the City of Dunedin (Otago R.D.). (S.O. 9129.)

In the Otago Land District; as the same is more particularly delineated on the plan marked P.W.D. 104059, deposited in the office of the Minister of Public Works at Wellington, and thereon coloured blue.
