TE AWAMUTU ELECTRIC-POWER BOARD.

RESOLUTION AMENDING SPECIAL RATE.

WHEREAS on the 24th day of June, 1938, a resolution was duly passed by the Te Awamutu Electric-power Board making a special rate of three-tenths of a penny ($\frac{3}{10}$ d.) in the pound upon the rateable value (on the basis of the unimproved value) of all rateable property of that portion of the Te Awamutu Electric-power District described in such resolution for the purpose of providing the interest and other charges on a loan of thirty thousand pounds (£30,000), authorized to be raised by the Te Awamutu Electric-power Board for the further reticulation of the said portion of the Board's District, including the purchase of all necessary material and plant, land and rights over land, and the payment of wages and engineering, survey, legal, and other fees. And whereas it has been ascertained that the said special rate of three-tenths of a penny ($\frac{3}{10}$ d.) in the pound will not be sufficient to meet such interest and other charges.

Now, therefore, the Te Awamutu Electric-power Board, in pursuance and exercise of the powers conferred on the Board by section 23 of the Local Bodies' Loans Act, 1926, hereby resolves that the said special rate of three-tenths of a penny ($\frac{3}{10}$ d.) in the pound shall be and is hereby amended by increasing such amount of three-tenths of a penny ($\frac{3}{10}$ d.) in the pound to three-hundred and thirty-six-one-thousandths of a penny ($\frac{3361}{100000}$ d.) in the pound.
