IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Wallace County Council, viz. :—

“The Wallace County Council being the local authority having control of the roads within the County, by resolution this fourth day of October, one thousand nine hundred and thirty-nine, declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the north-west side of Castle Street shown in red on plan, and abutting on the south-east boundary of Lot 1, D.P. 2798, Southland Land Registry Office, being part of Section 10, Block I, Jacob's River Hundred” ;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the north-western side of the portion of Castle Street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of road.

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the north-western side of the portion of New Street or the south-western side of the portion of Begg Street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-lines of the said portions of streets.

THE north-western side of all that portion of street known as New Street, situated in the Otago Land District, Borough of St. Kilda, fronting Lot 28, Block III, D.P. 68, Township of Musselburgh, being also part Section 68, Block VII, Town District.

Also the south-western side of all that portion of street known as Begg Street, situated in the said land district and borough, fronting Lots 26, 27, and 28, Block III, D.P. 68, Township of Musselburgh, being also part Section 68, Block VII, Town District.
