A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby revoke the Proclamation dated the seventh day of March, one thousand nine hundred and thirty-eight, and published in the *New Zealand Gazette*, 1938, at page 425, and deposited in the Land Registry Office at Auckland as No. 9595, in so far as it affects the land described in the Schedule hereto.
