WHEREAS the Maniototo County Council (hereinafter called "the said local authority"), being desirous of raising the sum of three thousand six hundred and seventy-five pounds (£3,675) by a loan to be known as "Bridges Loan, 1938" (hereinafter called "the said loan"), for the purpose of providing the Council's share of the cost of contingenerating bridge thereinatter that of erecting various bridges throughout the county, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council as required by the said Act should be given to the raising of the said loan:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of three thousand six hundred and seventy-five pounds (\pounds 3,675), and in giving such consent doth hereby determine as follows :—

(1) The term for which the said loan or any part thereof may be raised shall not exceed nineteen (19) years.

(2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate exceeding three pounds ten shillings (£3 10s.) per centum per annum.

(3) The said loan, together with interest on the outstanding balance thereof, shall be repaid by equal annual instalments of principal of not less than two hundred pounds ($\pounds 200$) each.

(4) The payment of such instalments and of interest in respect of the said loan shall be made in New Zealand and no amount payable as either interest or principal shall be paid out of loan-moneys.

(5) The rate payable for brokerage, underwriting, and procuration fees in respect of the raising of the said loan or any part thereof shall not in the aggregate exceed one-

half per centum of any amount raised. (6) No moneys shall be borrowed under this consent after the expiration of two years from the date hereof.
