IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the New Plymouth Borough Council on the twenty-first day of November, one thousand nine hundred and thirty-eight, viz. :—

“ That the New Plymouth Borough Council, being the local authority having control of the street hereinafter mentioned, hereby resolves and declares that the provisions of section one hundred and twenty-eight, subsection 1, of the Public Works Act, 1928, shall not apply to that portion of the northern side of Wallace Place to which Lot 9, Deposited Plan No. 4023, New Plymouth, has frontage ”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the northern side of the portion of Wallace Place (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of street.

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the eastern sides of the portions of streets (described in the Schedule hereto) within a distance of thirty-three feet from the centre-lines of the said portions of streets.

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Dunedin City Council, on the thirtieth day of January, one thousand nine hundred and thirty-nine, viz. :—

“ That the Dunedin City Council, being the local authority having control of the streets in the City of Dunedin, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the undermentioned portions of streets, viz. :—

- “ (a) The north-eastern side of portion of Maryhill Terrace abutting on part Lot 51, Glen Estate ; and
- “ (b) The south-eastern side of portion of Vickery Street, abutting on part Lot 52, Glen Estate ”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the north-eastern side of the portion of Maryhill Terrace, or the south-eastern side of the portion of Vickery Street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-lines of the said portions of streets.
