GALWAY, Governor-General. [L.S.] A PROCLAMATION.

IN pursuance and exercise of the powers and authorities yested in me by the Public West August authorities L vested in me by the Public Works Act, 1928, the Government Railways Act, 1926, and of every other power and authority in anywise enabling me in this behalf, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand. do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes of dwelling-sites for employees of the Government Railways Department.
