*Declaring a Bobby Calf Marketing Pool Area.*

**P**URSUANT to the Bobby Calf Marketing Regulations 1939, I, William Lee Martin, acting for the Minister of Marketing, being satisfied that a sufficient majority of the producers in the area of land defined in the Schedule hereto are desirous that such area should be declared to be a pool area for the marketing of bobby calves, do hereby declare such area of land defined as aforesaid, to be a bobby calf marketing pool area for the purposes of the said regulations under the name set out in the said Schedule, and I do hereby further declare that this notice shall take effect on the 6th day of July, 1939.

SCHEDULE.

DRURY BOBBY CALF MARKETING POOL AREA.

ALL that area of land lying entirely within the Franklin County and bounded by a line commencing at the point where the Main Trunk Railway crosses the southern boundary line of the Papakura Town District; thence continuing from this point in a straight line in a south-easterly direction to the point where it will meet the western boundary of Block I, Opaheke Survey District, at Section 20; thence continuing in a southerly direction along the western boundary of Block I; thence along the western boundary of Block V, Opaheke Survey District; thence continuing along the northern boundary of Block XII, Drury Survey District, to the point where this boundary line meets the boundary line of the Pukekohe Bobby Calf Marketing Pool Area; thence following the eastern boundary of the said pool area in a northerly and thence in a westerly direction to the point where it meets the northern boundary line of the Karaka Bobby Calf Marketing Pool Area at Section 62, Block VII, Drury Survey District; thence from this point, continuing along the western boundary line of the said Karaka Pool Area in a northerly direction to the point where it meets the southern boundary line of the Papakura Town District; thence continuing the line along this latter boundary line in an easterly direction to the point where it is crossed by the Main Trunk Railway, the original point of commencement.
