Vesting the Control of a Scenic Reserve in the Lake Kaniere Scenic Board.

GALWAY, Governor-General.

N pursuance and exercise of the powers and authorities L conferred upon him by section thirteen of the Scenery Preservation Act, 1908, His Excellency the Governor-General of the Dominion of New Zealand doth hereby vest the control of the reserve described in the Schedule hereto (being land reserved under the said Act), for the period of five years from the date hereof (unless previously altered or revoked under the said Act), in the undermentioned persons, namely,—
