

Revoking Part of a Proclamation taking Land in connection with the Proposed Work of levelling and forming Garden Place, in the Borough of Hamilton.

A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby revoke the Proclamation dated the tenth day of December, one thousand nine hundred and thirty-eight, and published in the *New Zealand Gazette* No. 92 of the fifteenth day of the same month at page 2773, and deposited in the Land Registry Office at Auckland as No. 9816, taking land in connection with the proposed work of levelling and forming Garden Place in the Borough of Hamilton, in so far as it affects the land described in the Schedule hereto, such land being no longer required.
