## WHAKATANE BOROUGH COUNCIL.

RESOLUTION MAKING SPECIAL RATE.

The following resolution was passed by the Whakatane Borough Council at its meeting held 13th May, 1940.

IN pursuance and exercise of the powers vested in it in in that behalf by the Local Bodies' Loans Act, 1926, the Whakatane Borough Council hereby resolves as follows:—
