*Adding a Constituent District to and Reapportioning Representation on the Wairarapa Electric-power Board.*

ORDER IN COUNCIL.

At the Government House at Wellington, this 22nd day of May, 1940.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers conferred by the Electric-power Boards Act, 1925, and of every other power in anywise enabling him in that behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby add portion of the County of Castlepoint as a constituent district of the Wairarapa Electric-power District, and doth hereby determine that on or after the dates of the next general elections of the representatives of the constituent districts of the Wairarapa Electric-power Board the number of representatives of each constituent district on the Wairarapa Electric-power Board shall be the number specified in the Schedule hereto opposite the name of that constituent district; and doth further determine that the constituent districts which are bracketed together in the first column of the Schedule hereto are hereby constituted a combined district for the purposes of the said Act, and that the principal local authority of such combined district shall be the local authority of the constituent district distinguished in the first column of the Schedule hereto by the letter "(p)."
