RESOLUTION MAKING AND LEVYING SPECIAL RATE.

York Bay Advances to Owners Private Connections Loan (1939) of £1,000.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Hutt County Council hereby resolves as follows:—

"That, for the purposes of providing the interest and other charges on a loan of one thousand pounds (£1,000), authorized to be raised by the Hutt County Council under the above-mentioned Act, for the purpose of carrying out certain public works, viz., advances to owners within the No. 41 York Bay Special Rating District for private sewerage connections (in terms of section 234, Municipal Corporations Act, 1933), the said Hutt County Council hereby makes and levies a special rate of one penny and three farthings in the pound (1½d. in the £) upon the rateable value (on the basis of the capital value) of all rateable property in the said No. 41 York Bay Special
