ADDITIONAL AREA.

PURSUANT to the Bobby Calf Marketing Regulations 1939, I, Walter Nash, Minister of Marketing, being satisfied that a sufficient majority of the producers in the area of land defined in the Schedule hereto are desirous that such area should be declared to be a pool area for the marketing of bobby calves, do hereby declare such area of land, defined as aforesaid, to be a Bobby Calf Marketing Pool Area for the purposes of the said regulations under the name set out in the said Schedule, and I do hereby declare that this notice shall take effect on the 30th day of August, 1940.

OHURA VALLEY BOBBY CALF MARKETING POOL AREA.

ALL that area of land situated within the Ohura County and bounded by a line commencing at the junction of the Ohura Road with the main highway, Section 1, Block IX, Tangitu Survey District; thence continuing along the main highway to Section 1, Block V aforesaid; thence along the northern boundary of Section 8, then southerly along the western boundary of Section 9 to the northern boundary of Section 13, Block V aforesaid; thence along the Tapuiwahine Road to the junction of the Kakara Road; thence continuing along the Kakara Road to its junction with the Ohura-Mokau Road; thence along the northern boundary of Section 4, Block VIII, Aria Survey District; thence in a westerly direction along the northern boundary of Section 1, Block XI, Aria Survey District, to the junction of the Waikaka Stream; thence westerly along the said stream to the boundary of Section 7, Block XI, Aria Survey District; thence in a northerly direction along the northern boundary of Section 7, to the point where it meets the boundary of Block X, Aria Survey District; thence northerly and westerly along the northern boundary of Block X, Aria Survey District, to the Waitewhena Road to the north-eastern corner of Section 1, Block IX, Aria Survey District; thence in a south-westerly direction along the boundaries of Sections 1 and 2, Block IX, Aria Survey District; thence in a southerly direction along the western boundaries of Sections 1, 2, and 3, Block XIII, Aria Survey District; thence in a westerly direction along the northern boundary of Section 2, Block I, Ohura Survey District; thence southerly along the western boundary of Section 2 aforesaid, to the southern boundary of Block X, Mokau Survey District; thence along the southern boundary of Block X aforesaid, to the Tawhitiraupaka Trig. Station 1,760 ft.; thence in a southerly, then easterly direction along the Ohura County boundary to the point where it meets the Waitaanga Stream; thence following the said stream in a northerly direction to the southern boundary of

Section 11, Block VII, Waro Survey District; thence along the southern boundaries of Sections 11, 12, 13, 14, 15, and 16, Block VII, Waro Survey District; thence in a south-easterly direction along the southern boundary of Section 10, Block VIII, Waro Survey District; thence in a southerly direction along the western boundary of Section 2, Block XII, Waro Survey District; thence along the southern boundary of Section 9, Block VIII, Waro Survey District; thence along the southern boundaries of Sections 22 and 10, Block V, Ohura Survey District; thence along the western boundary of Section 1, Block IX, Ohura Survey District; thence in a south-westerly direction along the north-western boundary of Section 1, Block XII, Waro Survey District, to the Tatu Trig. Station 1,974 ft.; thence southerly along the western boundaries of Sections 1 and 2, Block XVI, Waro Survey District; thence along the south-western boundary of Section 7, Block XIII, Ohura Survey District; thence in a southerly direction along the eastern boundary of Sections 5 and 4, Block IV, Pouatu Survey District, to the point where it meets the Ohura Road; thence in a straight line across country in an easterly direction to the point where it meets the junction of the Puhu Road; thence in a straight line across country to the south-eastern corner of Section 3, Block II, Heao Survey District; thence following the Ohura Stream to the junction of the said stream to the Opura Road; thence in a northerly direction along the eastern boundary of Sections 8 and 6; thence along the southern and eastern boundary of Section 4, Block VII, Heao Survey District, to the point where it meets the Opura Road; thence in a north-westerly direction along the north-eastern boundaries of Sections 3 and 2, Block VII aforesaid; thence along the north-eastern boundary of Section 3; thence along the eastern boundary and then northern boundary of Sub-section 6, Block III, Heao Survey District, to the point where it meets the Ohura River; thence following the Ohura River to the eastern boundary of Section 19, Block XIV, Ohura Survey District; thence northerly along the eastern boundaries of Sections 19, 18, and 17, Block XIV aforesaid, to the point where it meets the Ngutu Road; thence following the said road in a northerly direction to the point where it meets the Kururau Road; thence along the eastern boundary of Section 35, Block XIV, and Section 5, Block XI, Ohura Survey District, to the point where it meets the Kakahi Road; thence following the said road in a northerly direction to the southern corner of Section 9, Block VII, Ohura Survey District; thence along the south-western and north-western boundary of Section 9, Block VII aforesaid, to the point where it meets the Waitangata Road; thence following the said road in a north-westerly direction to the western corner of Section 2, Block IV, Ohura Survey District; thence following the boundary of the said section in a northerly, then southerly direction to where it meets the northern boundary of Section 8, Block IV, Ohura Survey District; thence along the southern boundaries of Sections 6 and 7, Block IV, Ohura Survey District, to the south-eastern corner of Section 3, Block IV, Ohura Survey District; thence northerly along the eastern boundary of Section 3, Block IV aforesaid, to where it meets the Makara Stream; thence along the southern and then eastern boundary of Section 19, Block I, Rangi Survey District, to the point where it meets the Otahu Stream; thence along the southern and eastern boundary of Section 9, Block XI, Tangitu Survey District; thence along the southern boundaries of Sections 3, 4, 5, and 6, Block XI aforesaid, to the south-eastern corner of Section 6, Block XI aforesaid; thence along the eastern boundary of Section 6, Block XI aforesaid; thence along the southern boundary of Section 2, Block XI aforesaid; thence along the southern boundaries of Sections 1 and 2, Block XII, Tangitu Survey District; thence along the western and then northern boundary of Section 3, Block XII aforesaid; thence along the eastern boundaries of Sections 4, 3, and 1, Block IX, Tangitu Survey District, being the original point of commencement.

PURSUANT to Regulation 5: 1 of the Lemon Marketing Regulations 1940, I hereby fix the following prices per bushel to be paid by the Marketing Department for lemons of fancy grade and commercial grade respectively delivered to the Department during the undermentioned period.

The prices are fixed on an average basic price of 6s. 3d. for sufficient fruit which when cured will pack a bushel case.
