IT is hereby notified for public information, in accordance with the provisions of subsection (7) of section 15 of the Meat Act, 1939, that—

1. By deed of agreement dated the 1st day of May, 1941, made between the respective corporations of the Borough of Cambridge, the Leamington Town Board District, and the Counties of Waikato, Matamata, and Waipa, the abattoir established for the Borough of Cambridge has been made available for the district within the jurisdiction of the Leamington Town Board and for those parts of the respective districts within the jurisdiction of the said counties as hereinafter described ;

2. The Cambridge Abattoir District, as affected by the said agreement, shall comprise all that area described in the Schedule hereto ; and,—

3. The Council of the Borough of Cambridge shall be the controlling authority of the abattoir for the purposes of the said abattoir district described in the said Schedule.
