WHEREAS the Gore Borough Council (hereinafter called "the said local authority") being desirous of raising the sum of three thousand pounds (£3,000) by a loan to be known as "Baths Loan, 1941" (hereinafter called "the said loan") for the purpose of erecting public swimming baths for Gore, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council as required by

consent of the Governor-General in Council as required by the said Act should be given to the raising of the said loan : Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in action transfer of the Simanga Act 1922 (No. 2). conterred on him by section eleven of the said Act, as set out in section twenty-nine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of three thousand pounds (53,000), and in giving such consent doth hereby determine as follows :
