In the application of the foregoing prices each delivery of milk at any premises not being those of the vendor or purchaser of such milk shall be treated as if it were a separate sale of such milk to the occupier of such premises.

Wherever reference is made herein to "milk district" or "district" this shall be deemed to be a reference to the Auckland Metropolitan Milk District constituted as above mentioned.

The prices hereby fixed shall not affect in any way the prices fixed by resolution of the Auckland Metropolitan Milk Council dated the 16th August, 1940, relating to sales to manufacturers of ice-cream or confectionery or with those fixed by resolution of the said Council dated the 14th February, 1941, relating to milk for use in schools.

5. This Order is to continue until the 30th day of September, 1941, or until such earlier time as the Tribunal with the authority of the aforesaid Minister fixes different prices from those above mentioned.

2. The maximum price at which three-in-one oil packed in the size specified in the first column of the Schedule hereto may be sold in New Zealand to a wholesaler, a retailer, or a

consumer shall be not more than the price set out in the second, third, and fourth columns respectively of the said Schedule underneath each such type of sale and opposite each such size.
