IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the First Schedule hereto and all the estates and interests of Elizabeth Bellamy Dixon, Charlotte Dixon, Caroline Dixon, Spinsters, all of Brightwater, Alice Lines, of Westport, Widow, Margaret Olive Max, of Brightwater, Spinster, George William Hall, of Brightwater, Cycle Agent, Jabez George Hill, Farmer, and Walter Hill, Farmer, both of Brightwater, in the land described in the Second Schedule hereto being rights-of-way thereover created by Conveyance 38553 (Deeds Index, Volume 4, folio 96), Nelson Registry, are hereby taken for the purposes of a recreation-ground; and I do also declare that this Proclamation shall take effect on and after the fourteenth day of July, one thousand nine hundred and forty-one.
