And, in further pursuance of the provisions of the said section 147 of the Municipal Corporations Act, 1933, the boundaries of the Papakaio Riding of the County of Waitaki affected by the said Order in Council are hereby defined as set out in the Third Schedule hereto.

Deeds by a straight line to the north-western corner of Lot 1, Deeds Plan 339, deposited as aforesaid; thence south-easterly along the north-eastern side of a public road to Orwell Street; thence north-easterly across the aforesaid public road and along the north-eastern side of Orwell Street to the Oamaru Town Boundary Road; thence south-westerly along the Oamaru Town Boundary Road to Oamaru Creek; thence north-westerly generally by that creek to Block I, Papakaio Survey District, thence westerly along the southern boundary of that block to the western boundary of Papakaio Survey District, thence northerly along that boundary to the southern boundary of Block IV, Awamoko Survey District; thence westerly along that boundary to the eastern boundary of Section 5s, Pukenui Settlement; thence along the eastern, southern, and western boundaries of that section to Section 4s, aforesaid settlement; thence north-westerly along the western boundary of said Section 4s to a public road; thence westerly along that road to Section 15a, Plunket Settlement; thence northerly and westerly along the eastern and northern boundaries of that section to the eastern boundary of Block V, Awamoko Survey District; thence northerly along that boundary and the eastern boundary of Block II, Awamoko Survey District, to the point of commencement.
