

MANUKAU COUNTY COUNCIL.

RESOLUTION MAKING SPECIAL RATE.

Quarry and Buildings Loan, 1941, £4,500.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, the Manukau County Council Empowering Act, 1941, and all other powers enabling it in that behalf, the Manukau County Council hereby resolves as follows:—

“That, for the purpose of providing the interest, principal, and other charges on a loan of £4,500, authorized to be raised by the Manukau County Council under the above-mentioned Acts for the purpose of acquiring a quarry and buildings at Mangere in the County of Manukau, the said Manukau County Council hereby makes and levies a special rate of one-fiftieth of a penny ($\frac{1}{50}$ d.) in the pound (£) on the rateable value (on the basis of the capital value) of all rateable property in the County of Manukau, and that such special rate shall be an annual-recurring rate during the currency of such loan and be payable on the 1st day of September in each and every year during the currency of such loan, being a period of twenty years or until the loan is fully paid off.”

I, Frank McIntyre Waters, Chairman of the Manukau County Council, hereby certify that the above is a correct extract from the minutes of proceedings of a properly constituted meeting of the Manukau County Council held on the 18th day of November, 1941.
