A PROCLAMATION.

ORDER IN COUNCIL.

At the Government House at Wellington, this 25th day of November, 1942.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of every other power in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Dunedin City Council on the twentieth day of July, one thousand nine hundred and forty-two, viz.:—

“That the Dunedin City Council, being the local authority having control of the streets in the City of Dunedin, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the south-eastern side of the portion of Highgate adjoining subdivision of part Lot 8, Deeds Plan 103, Block V, Township of Roslyn, such land being comprised and described in Certificate of Title 254/55, Ltd.”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the south-eastern side of the portion of Highgate (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of street.

SCHEDULE.

THE south-eastern side of all that portion of street situated in the Otago Land District, City of Dunedin, known as Highgate, fronting part Lot 8, Deeds Plan 103, Township of Roslyn, and being part Section 27, Block IV, Upper Kaikorai District. As the same is more particularly delineated on the plan marked P.W.D. 114948, deposited in the office of the Minister of Public Works at Wellington, and thereon coloured red.
