PURSUANT to Regulation 4 of the Delivery Emergency Regulations 1942 the Minister of Theorem lations 1942, the Minister of Transport doth hereby give notice as follows :--

 Delivery Notice 1942.
 This notice shall come into force on the seventh day after

the date of publication thereof in the Gazette.

### SCHEDULE.

THE DANNEVIRKE COMMODITIES DELIVERY SCHEME, 1942.

- (1) For the purposes of this scheme, unless the context otherwise requires,-

- "Commodities" means bread, fruit, and vegetables:

  "The district" means the area within a radius of two miles from the Chief Post-office, Dannevirke:

  "Wholesale purchaser" means a person who purchases commodities for resale or for transport to an area outside the district or for consumption at a military camp, hotel, hospital, or similar institution requiring large supplies of commodities daily.
- (2) It shall be a condition of this scheme that the commodities shall be delivered within the district to the premises of wholesale purchasers only.
