No person being the owner thereof shall sell, supply, dispose of, or part with the possession or control of any new or used tires or tubes to which this notice applies and which are not affixed to a vehicle as part of the normal equipment thereof except with the precedent consent of the Secretary, Ministry of Supply and Munitions (as delegate of the Munitions Controller), or of some other person appointed by the Secretary for the purpose.
