In pursuance and exercise of the powers and authorities conferred on me by section fourteen of the Counties Act, 1920, and of all other powers and authorities enabling me in that behalf, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area described in the First Schedule hereto, being now part of the Pahiatua County, shall be added to and form part of the Kairanga County; that the boundaries of the Kairanga and Pahiatua Counties as so altered shall be those set forth under the respective headings in the Second Schedule hereto; that the area added as aforesaid to the Kairanga County shall be included in the Fitzherbert Riding of the said county; and that the boundaries of the Fitzherbert Riding as so altered shall be those set forth in the Third Schedule hereto.
