A PROCLAMATION.

BY virtue and in exercise of the powers and authorities conferred upon me by section eighteen of the Forests Act, 1921-22, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby set apart the Crown land described in the Schedule hereto as a provisional State forest.

SCHEDULE.

WELLINGTON LAND DISTRICT.—WELLINGTON CONSERVANCY.

ALL that area in the Wellington Land District, Kaitieke County, containing by admeasurement 333 acres, more or less, being Taurewa West A No. 4C Block, situated in Block III, Waimanu Survey District. As the same is more particularly delineated on plan No. 52/10, deposited in the Head Office of the State Forest Service at Wellington, and thereon bordered red.
