## The Palmerston North Bread Delivery Notice 1942.

PURSUANT to Regulation 4 of the Delivery Emergency Regulations 1942\*, the Minister of Transport doth hereby give notice as follows :

This notice may be cited as the Palmerston North Bread Delivery Notice 1942.
 This notice shall come into force on the Monday following the date of publication thereof in the *Gazette*.

## SCHEDULE.

## THE PALMERSTON NORTH BREAD DELIVERY SCHEME, 1942.

(1) For the purposes of this scheme, unless the context otherwise requires,-

"The district" means the area of the City of Palmerston North and Milson Settlement :

"Minister" means the Minister of Transport : "Wholesale purchaser" means either—

(a) A person who purchases not less than thirty-six 2 lb. loaves per week or their equivalent in weight; or (b) A hospital.

Palmerston North Bread Delivery Committee-

(a) Two members to be appointed by the Palmerston North City Council;
(b) One member to be appointed by the Manawatu, Southern Hawke's Bay, and Wairarapa Master Bakers' Association;
(c) The Zoning Officer for the North Island.

(3) (a) The members to be appointed to the committee by the Palmerston North City Council and the Manawatu, Southern [Hawke's Bay, and Wairarapa Master Bakers' Association under clause (2) of this scheme shall be appointed by resolution of the Council and Association respectively as soon as may be after the coming into force of this scheme. (b) Any committee member appointed by the said Council or Association, as the case may be, may in like manner be removed from office.

(4) Any committee member, other than the Zoning Officer, may resign his office by writing addressed to the Minister.

(5) On the death, resignation, or removal from office of any committee member, other than the Zoning Officer, the vacancy created thereby shall be filled by appointment in the manner in which the vacating member was appointed.
(6) The functions of the committee shall be to receive and investigate complaints affecting the administration of this scheme in its area, to advise the Minister on any matters that may be referred to the committee by the Minister or that may be considered by it of its own motion, and to make recommendations to the Minister for amending this scheme.
