I ANOCHMENTION. IN pursuance and exercise of the powers conferred by section twelve of the Land Act, 1924, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim as closed the portion of road described in the Schedule hereto.

SCHEDULE.

APPROXIMATE area of the piece of road closed : 22 acres. Adjoining or passing through Section R. 1451.

Situated in Blocks XI and XII, Hohonu Survey District (Westland R.D.). (S.O. 4322.)

In the Westland Land District; as the same is more particularly delineated on the plan marked P.W.D. 115240, deposited in the office of the Minister of Public Works at Wellington, and thereon coloured green.

ORDER IN COUNCIL.

At the Government House at Wellington, this 30th day of September, 1942.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

In pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of every other power in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Peninsula County Council on the sixteenth day of July, one thousand nine hundred and forty-two, viz. :--

"The Peninsula County Council, being the local authority having control of the roads in the Peninsula County, by resolution declares the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the northern side of portion of District Road fronting part of Lot 4, D.P. 2362, Township of Wharfdale, being part of Section 18, Upper Harbour East District ";

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the northern side of the portion of District Road (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of road.
