Borough Council hereby resolves as follows :— "That, for the purpose of providing principal, interest, and other charges on a loan of £2,300, authorized to be raised by the Te Awamutu Borough Council under the above-mentioned Act, for the purpose of dedicating and constructing a new street from Alexandra Street west of the railway-line to Tawhaio Street, including the purchase of land and erecting fencing, the said Te Awamutu Borough Council hereby makes and levies a special rate of threesixteenths of a penny ( $\frac{1}{R}$ d.) in the pound upon the rateable value of all rateable property of the Borough of Te Awamutu, comprising the whole of the said borough; and that such special rate shall be an annual-recurring rate during the currency of such loan and be payable yearly on the 1st day of August in each and every year during the currency of such loan, being a period of twenty years or until the loan is fully paid off."
