IN pursuance and exercise of the power and authority conferred upon me by subsection one of section eight of the Housing Amendment Act, 1940, I, Cyril Louis Norton Newall, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare the land described in the First, Second, and Third Schedules hereto, being land subject to the Housing Act, 1919, to be Crown land available for reservation under the Land Act, 1924.

### FIRST SCHEDULE

# MARLBOROUGH LAND DISTRICT

MARLBOROUGH LAND DISTRICT

ALL that area containing by admeasurement 2 roods 16·3 perches, situated in the Borough of Blenheim, being part of Section 50, District of Omaka, and being also Lot 18 on Plan 1659, deposited in the office of the Chief Surveyor, Blenheim. As the same is more particularly delineated on the plan marked L. and S. 1/1107/7, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon edged red.

## SECOND SCHEDULE
