ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of every other power in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Waimea County Council on the eleventh day of June, one thousand nine hundred and forty-three, the sides and portions of roads affected by such resolution being more particularly described in the Schedule hereto, viz.:-

"The Waimea County Council, being the local authority having control of the roads in the County of Waimea, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the south-western and north-western sides of the public roads adjoining part Section 148, Waimea East, Block VI, Waimea Survey District, and contained in Certificate of Title, Volume 57, folio 295";

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the north-western side of portion of public road and the south-western side of portion of public road (described in the Schedule hereto) within a distance of thirty-five feet from the centre-lines of the said portions of roads.

SCHEDULE

THE north-western side of all that portion of public road situated in the Nelson Land District, County of Waimea, fronting part Section 148, District of Waimea East, Block VI, Waimea Survey District.

Also the south-western side of all that portion of public road situated in the said land district and county, fronting part Section 148, District of Waimea East, Block VI, Waimea Survey District.

As the same are more particularly delineated on the plan marked P.W.D. 117365, deposited in the office of the Minister of Works at Wellington, and thereon coloured red.
