“ The Marlborough County Council, being the local authority having control of the roads in the County of Marlborough, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the public road running through and the eastern side of Jackson’s Cross Road adjoining Sections 94, 95, 96, and 97, Wairau West, Block X, Cloudy Bay District, and contained in Certificate of Title, Volume 30, folio 278 ” ;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the eastern side of the portion of Jackson’s Cross Road and the portion of an unnamed road (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portions of roads.
