Servicemen's Settlement and Land Sales Act, 1943.— Notice declaring Land taken for the Settlement of a Discharged Serviceman

WHEREAS an application has been made for the consent of the Land Sales Court to a transaction which relates to the land described in the Schedule hereto and to which Part III of the Servicemen's Settlement and Land Sales Act,

Part III of the Servicemen's Settlement and Land Sales Act, 1943, applies:

And whereas the Land Sales Committee to which the application has been referred is of opinion that the land to which the application relates is farm land suitable for the settlement of a discharged serviceman:

And whereas the said committee, not being satisfied that the Crown had decided not to acquire or arrange for the acquisition of the land, did on the 22nd day of June, 1944, make an order determining the basic value of the land and no appeal from the said order was made within the time prescribed by the said Act or within any further time allowed by the Court:

And whereas the said land is not the land of any serviceman who is for the time being serving outside New Zealand in any of His Majesty's Forces or in any British ship:

Now, therefore, I, Clarence Farringdon Skinner, Minister of Lands, acting in pursuance of section 51 of the said Act, do hereby declare that the said land is taken for the settlement of a discharged serviceman, and I hereby specify the 7th day of August, 1944, as the date on which the said land shall be deemed to be vested in His Majesty the King.

The Serpentine Superphosphate Control Order 1944

In pursuance and exercise of the powers conferred on him by the Primary Industries Emergency Regulations 1939,* the Minister of Agriculture doth hereby make the following Order.

ORDER

1. This Order may be cited as the Serpentine Superphosphate Control Order 1944, and shall come into force on the 1st day of August, 1944.

2. (1) The Serpentine Superphosphate Control Order 1943† is hereby revoked.(2) The revocation of the said Order shall not affect the liability

of any person for any offence in relation thereto committed before the commencement of this Order.

3. While this Order continues in force no person shall manufacture for sale or shall cause or permit to be manufactured for sale or shall pack for purposes of sale any serpentine superphosphate that fails to comply in any particular with the standards prescribed in the first column of the Schedule hereto by more than the permitted margin of tolerance (if any) specified in relation thereto in the second column of that Schedule.

4. While this Order continues in force no person shall use or shall cause or permit to be used in the manufacture of serpentine superphosphate intended for sale any serpentine rock that fails to comply in any particular with the standards prescribed in the first column of the Schedule hereto by more than the permitted margin of tolerance (if any) specified in relation thereto in the second column of that Schedule.
